# NCoC Board of Directors

## Garrett M. Graff (Chair)

---

Garrett M. Graff, the board chair of the National Conference on Citizenship, is a distinguished magazine journalist and historian and has spent more than a dozen years covering politics, technology, and national security. Today, he serves as the director of the Aspen Institute's cybersecurity and technology program, and is a contributor to WIRED, Longreads, and CNN. He's written for publications from Esquire to the New York Times, and served as the editor of two of Washington's most prestigious magazines, Washingtonian and POLITICO Magazine, which he helped

lead to its first National Magazine Award, the industry's highest honor.



Graff is the author of multiple books, including *The First Campaign: Globalization, the Web, and the Race for the White House*, which examined the role of technology in the 2008 presidential race, and *The Threat Matrix: The FBI At War*, which traces the history of the FBI's counterterrorism efforts. His most recent book, *Raven Rock*, about the government's Cold War Doomsday plans, was published in May 2017.

## Barry Byrd

---

Barry Byrd is a partner at the law firm of Pineiro Byrd PLLC, in Jupiter, Florida, specializing and Board Certified in real estate law. Barry is a graduate of Stetson University and the Stetson College of Law. He has practiced for over 30 years. Barry has served on boards of several publicly traded companies, held leadership positions in numerous community

organizations and served as president of the Northern Palm Beaches Chamber of Commerce. He currently chairs the Abacoa Partnership for Community and serves as a director of the Boys & Girls Clubs of Palm Beach County.



## Dr. Lattie Coor

---

Dr. Lattie Coor founded the Center for the Future of Arizona in 2002 with the goal of creating an Arizona in which there are opportunities and quality of life for all citizens, now and in the future. Under his direction, the center has focused upon collaborative initiatives such as creating

a unified state vision and action plan, and implementing the Beat the Odds research findings in Arizona K-12 schools. He also is the Ernest W. McFarland Arizona Heritage Chair in Leadership and Public



Policy and a professor of public affairs at Arizona State University. Dr. Coor is a highly regarded Arizona statesman and esteemed president emeritus of Arizona State University (1990-2002)

and the University of Vermont (1976-1989). As president of ASU, Dr. Coor elevated the university's status as a major research institution with high-quality academics and a diverse student body.

## Phil Duncan

---

Phil Duncan serves on the Falls Church, Virginia, City Council and is president of Civicatalyst Communications, a consulting firm focusing on civic participation and education. A native of East Tennessee, Phil is a graduate of Davidson College, where he edited the student newspaper. He worked at The Charlotte Observer and The Knoxville News Sentinel, then for twenty years at Congressional Quarterly as a politics reporter and editor. He served four years as executive director of NCoC. Prior to his 2012 election to City Council, Phil was a founding board member of the

Falls Church Education Foundation, chairman of the City Schools' Business in Education Partnership, and vice chairman of the Falls Church Chamber of Commerce, receiving its "Pillar of the Community" award in 2001. Phil is President of the Duncan Educational Fund, Inc., which assists exceptional students in Scott County, Tenn., where his grandmother was a longtime teacher. He and his wife Leslie have a daughter and a son.



## Paula Ellis

---

Paula Ellis, a former Knight Foundation officer, senior publishing executive and journalist, has long been a leader in journalism innovation and community engagement. She has decades-long experience in the for-profit, nonprofit and government sectors. As vice president for strategic initiatives at the Knight Foundation, Ellis shaped the "informed and engaged" strategy, shifted the evaluation focus and launched a series of initiatives that would become signature efforts. Ellis began her career as a journalist at several metropolitan newspapers. In 1980, she joined Knight Ridder Inc. where she worked

for 26 years rising through the ranks as an editor, publisher and vice president/operations of the Fortune 500 firm she helped sell in 2006. Known for innovation and collaboration, Ellis often was tapped to lead key strategic efforts. A respected national journalist, she also delivered operational excellence. The Sun News in Myrtle Beach was Knight-Ridder's top performing news organization for five of the seven years she led it.

Ellis is a trustee of the Poynter Institute for Media Studies, a member of the



Knight Commission on Intercollegiate Athletics, and board member of Grassroots Grantmakers and the Philip Merrill College of Journalism (University of Maryland) board of visitors.

Ellis earned a bachelor's degree in

government and politics at the University of Maryland, where she was editor of the nation's best student daily. She graduated from Northwestern University with a master's degree in journalism and has been an adjunct faculty member at several universities.

## Eric K. Federing

---

Eric K. Federing, of Maryland, serves as honorary director of the National Japanese American Memorial Foundation, which is focused on Washington, D.C.'s National Japanese American Memorial to Patriotism in World War II. Federing was a director of the Foundation from 2003 to 2013. He has been listed in Who's Who in America annually since 2000, served for a dozen years as a senior advisor in the United States Senate and House of Representatives, and is a graduate of George Washington University, Phi Beta Kappa.

Internationally, Eric founded the non-partisan Uni-Capitol Washington Internship

Programme in 1999, which he continues to direct pro bono and through which Australian university students are matched to select congressional offices annually for 2-month internships. On May 27, 2015, the Australian Government appointed Eric as a Member (honorary) in the Order of Australia. Professionally he is currently managing director at KPMG LLP, the global auditing, advisory and tax firm. He is a senior strategic advisor to the firm's management, practices, partners, and clients.



## Hon. Bob Graham

---

One of the most accomplished politicians in Florida's history, Bob Graham never lost an election for office in more than four decades of public service at the local, state and national level. As first a state legislator, then governor and finally a three-term U.S. Senator, Graham has had a role in nearly every major public policy issue in modern Florida's history.

Having personally witnessed Florida's rise

from a predominantly rural Southern backwater to an economic and political juggernaut that is now the nation's fourth largest state, he created the Bob Graham Center in Public Service to continue his legacy of leadership and train the next generation of Sunshine State leaders.

At the University of Florida, he was



a political science major, and won some of the school's most prestigious awards including induction into the University of Florida Hall of Fame.

After graduating from Harvard Law School, Graham returned to his native Miami Lakes and won a seat in the Florida House of Representatives as part of a group of young progressive Democrats sympathetic to civil rights, public education and the environment. The group was known as the Doghouse Democrats, because their liberal credentials often landed them in the doghouse with the conservative

Democrats who controlled the state.

Graham was elected Florida's governor in 1978, and after serving two terms, Graham joined the U.S. Senate in 1987, carving out a career known not only for his grasp of domestic issues like Everglades restoration, immigration and off-shore drilling, but as a leading expert on foreign policy and intelligence.

One of Graham's most important contributions came during his last term, when he was named chairman on the Senate Select Committee on Intelligence.

## Gail Leftwich Kitch

---

Gail Leftwich Kitch is chief operating officer of The Voter Participation Center, a research-driven, results-oriented nonprofit, nonpartisan organization dedicated to increasing the participation of unmarried women, young people and minorities, historically underrepresented groups in our democracy. Most recently, she served as executive director of By the People, a MacNeil/Lehrer Productions project which uses public television to encourage and support informed non-contentious citizen dialogue around policy issues. Mrs. Kitch was president of the Federation of State Humanities Councils, the national membership organization of the state

affiliates of the National Endowment for the Humanities, following service as director of Cambridge Forum, in Cambridge, Massachusetts. She is a former chair of the Massachusetts Foundation for the Humanities, and was a Radcliffe College Public Policy Fellow in the late 90s. Among other activities, Mrs. Kitch currently serves on the Executive Committee of the Boards of the Women's Foreign Policy Group and National History Day. She has a B.A. from Bryn Mawr College and a J.D. from the University of Chicago Law School.



## A. G. Newmyer III

---

A. G. Newmyer III, known as "Terry," is an active investor and management consultant. He was founder of U.S. Fiduciary Advisors, a network of highly-

trained individuals who serve as fiduciaries, and runs the firm's Palm Beach office.



For two decades starting in the early 1970's, he was an officer of Newmyer Associates, management consultants in Washington, D.C. Terry graduated with senior honors from Andover and earned his B.A., cum laude, at Yale.

He serves on a half-dozen non-profit and private sector boards. Much of his non-profit work is focused on the evolution of our nation's health care system.

## Craig Turk

---

Craig Turk, of California, is a political consultant and screenwriter. Craig graduated from Harvard College with high honors, pursued graduate studies in politics at Oxford University, and earned his law degree, with honors, at Harvard. He served as chief counsel of John McCain's presidential campaign, and has practiced law in Washington and California. Craig

advises political parties in Europe and Asia, as well as domestically. He has advised the Sam Rainsy Party in Cambodia and the Government of Montenegro. He has also written for television shows including "Law & Order." Craig is a board member of the Epilepsy Foundation in Los Angeles.



## Michael Weiser (Chair Emeritus)

---

Michael Weiser was elected chairman of the National Conference on Citizenship in January 2008. An investor and writer, Mr. Weiser is a frequent commentator on issues relating to finance, citizenship and community-building for The Washington Times, Miami Herald, Chicago Tribune, The Street.com and other media. Mr. Weiser serves as a general partner of

Lowell Associates, LP, a private investment partnership. A former financial journalist and communications consultant, Mr. Weiser received a Bachelor's in Journalism from the University of Missouri. He resides in New York City and Miami with his wife, Julie Greiner Weiser.

## Sterling Speirn

---

Sterling Speirn was appointed chief executive officer by the Board of Directors in November 2017. He is the immediate past president and CEO of the Peninsula Community Foundation (now the Silicon Valley Community Foundation), and the W.K. Kellogg Foundation (WKKF). Before his career with community and private foundations, Mr. Speirn got started in corporate philanthropy leading the Community Grants program at Apple Computer.

From these philanthropic platforms, Mr. Speirn has been a long-time investor in efforts to promote civic and community engagement as well as service and volunteering. He has championed support for local and national dialogues in partnership with organizations such as America Speaks, the National Center for Deliberative Democracy, Public Agenda, the Harwood Institute, Everyday Democracy, and many others.

At PCF he founded the Center for Venture Philanthropy, created the Peninsula Partnership for Children, Youth and Families, and launched the Raising a Reader take-home book program which today operates in 34 states at 2,700 sites serving more than 125,000 children

annually. Also during this time, Mr. Speirn taught a seminar on philanthropy at the Stanford Graduate School of Business, and PCF's innovations in donor services were profiled in a Harvard Business School Case Study.

At WKKF he helped launch America Healing, a five-year, \$75 million initiative to support programs that promote racial equity and address structural racism. He was a champion for early childhood education, and worked to expand and integrate the pioneering legacy of food systems work that built the food movement in the United States. He promoted civic and community engagement in alignment with place-based philanthropy, and helped create a \$100 million Mission Driven Investment Fund that built a portfolio of private double bottom line investments in alignment with the foundations programmatic and place-based focus areas.

He currently serves on the Board of Directors of the Greater Washington Community Foundation and is a member of the Racial Equity Working Group of the Washington Regional Association of Grantmakers.

## Jeff Coates

---

As Director of Research, Jeff Coates is responsible for organizational priorities that include conducting research, performing data analysis as part of the Civic Health Index initiative, and evaluation of programs. His prior experience in disaster relief and long-term recovery has given him the knowledge of various fields including community development, civic engagement, and economic development.

He previously worked at the Knight Foundation as Strategic Initiative Associate from 2010 to 2013, where he managed grants totaling over \$20 million including supporting Knight's Soul of the Community project. He also co-founded the Recovery Action Learning Laboratory

(RALLY) Foundation, a New Orleans-based nonprofit that monitored and evaluated post-disaster programs. He has worked in disaster recovery in Sri Lanka, where he worked with the Government of Sri Lanka in assessing food distribution to internally displaced people following the 2004 Tsunami.

Coates was also a Peace Corps volunteer stationed in Guyana. Jeff earned a Bachelor of Arts in anthropology from the University of Oklahoma and a Master of Public Health from Tulane University in New Orleans.



## Lisa Matthews

---

Lisa Matthews, program director, was appointed to her position in October 2016 to support the Board of Directors and staff in advancing the Civic Health Initiative and its Civic Health Index (CHI) program. Additionally, Matthews provides support to the Annual Conference on Citizenship and year-round activity designed to advance the NCoC mission of Strengthening Civic Life in America.

In addition to more than 20 years of experience as a research analyst for a

nonprofit association, Matthews is a volunteer at the local, state and national levels focused on issues related to empowering individuals with disabilities, capacity building and economic development.

Matthews was recently appointed by Mayor Muriel Bowser to serve as chair of the DC Developmental Disabilities Council.

Matthews is listed in the 2017-2018 publication of Who's Who in America.

## Angela Holden

---

Angela Holden has over seven years of administrative experience supporting a variety of organizations in the field of media, construction and healthcare. Previously, Angela served as an executive assistant for a nonprofit organization that helped underserved populations gain access to much needed healthcare services. Angela completed her Associate's Degree in Business Administration and

is currently pursuing her Bachelor's of Science in Business Administration. Each year, Angela volunteers for a summer program that provides adaptive surfing for people with spinal cord injuries. In her free time, Angela enjoys reading, hot yoga and traveling to new places.



## Honorees

### Brenda "Sue" Fulton

---

Sue Fulton is a 1980 West Point graduate, part of the first class to admit women. She was commissioned in the Army, served as a platoon leader and company commander in Germany, and was honorably discharged at the rank of Captain. In 2009, she co-founded Knights Out, the organization of LGBT West Point alumni and allies, and a year later became a founding board member of OutServe, the association of actively-serving LGBT military members; in both roles she was an active advocate for the repeal of "Don't Ask, Don't Tell." As President of SPARTA, she played a leading role in lifting the military's ban on transgender service in 2013.

In July 2011 she was appointed by President Obama as the first openly gay member of the West Point Board of Visitors, and became the first female USMA graduate to chair the Board in 2015. In 2017, she was appointed to

the Board of Visitors for the National Defense University in Washington, DC; she was also recognized as one of NBC Out's first #Pride30, a list of innovators, changemakers, and rising stars.

In 2018, New Jersey Governor Phil Murphy nominated Fulton to be Chair & Chief Administrator of the state's Motor Vehicle Commission, the first openly gay member of the Cabinet. Recently, she was appointed to the State Ethics Commission, and joined the American Association of Motor Vehicle Administrators (AAMVA) Board of Directors.

In December, 2012, after 17 years together, Fulton and her partner Penny Gnesin became the first same-sex couple to marry in the West Point Cadet Chapel. They live in Asbury Park, NJ.



## G. S. “Mack” McCarter, III

---

Mack is founder and coordinator of Community Renewal International. A native of Shreveport, LA, Mack holds a Bachelor of Arts degree in religion from Texas Christian University and a Master of Divinity Degree from Brite Divinity School. He served as a pastor for 18 years in Texas before returning to Shreveport in 1991 to begin implementing his vision for community renewal. ## John C. Bonifaz

---



John Bonifaz is the Co-Founder and President of Free Speech For People, a national campaign that works to renew our democracy and our United States Constitution for we the people, not big money and corporate interests. Free Speech For People (FSFP) challenges corruption at the highest levels of our government; catalyzes and advances the movement to amend the U.S. Constitution to overturn the Supreme Court's Citizens United and Buckley v. Valeo rulings and the fabrication of corporate constitutional rights; and engages in legal advocacy in the courts to confront the doctrines underlying the Citizens United and Buckley decisions.

John Bonifaz previously served as the executive director and general counsel of the National Voting Rights Institute (NVRI), an organization he founded in 1994. Mr. Bonifaz also previously served as the legal director of Voter Action, a national election integrity organization.

Mr. Bonifaz has been at the forefront of key voting rights battles in the United States for more than two decades: pioneering a series of court challenges, applying political equality principles, that have helped to redefine the campaign

finance question as a basic voting rights issue of our time; initiating and leading a legal strategy for revisiting Buckley v. Valeo in the courts; leading the fight in the federal courts in Ohio for a recount of the 2004 presidential vote in that state; and prevailing in federal court in Pennsylvania on the eve of the 2008 election in an emergency paper ballot case. He is the co-author with former American University Law Professor and now Congressman Jamin B. Raskin of two seminal law review articles (Yale Law & Policy Review-1993 and Columbia Law Review-1994) and of The Wealth Primary: Campaign Fundraising and the Constitution, published by the Center for Responsive Politics in 1994, all of which argue that the current campaign finance system violates the Equal Protection rights of non-wealthy candidates and voters.

Mr. Bonifaz is a 1992 cum laude graduate of Harvard Law School and a 1999 recipient of a MacArthur Foundation Fellowship. He has written and spoken extensively across the country on pressing democracy and voting rights issues facing the nation today.

Lieberman was the Lead Organizer for the Coalition for Campaign Finance Reform in St. Pete and was very involved in the passage of the "Protect our Democracy" ordinance in St Petersburg. The coalition was comprised of 30 local and national organizations. The ordinance, which passed on October 5th, 2017, included two segments for St Pete elections: (1) abolishing super PACs and (2) limiting donations by foreign corporations. The ordinance became law on January 1, 2018. If it is challenged, it will go to the US Court of Appeals Eleventh Circuit. If it is upheld in the Eleventh Circuit and then appealed, it will go to the U.S. Supreme Court. Because of this trajectory, the case has the potential to take a big bite out of Citizen's United.

Other current community work: League of Women Voters St Pete, chair, social justice group, interfaith work around homelessness and affordable

housing, organizing for gun safety laws and the repeal of Stand Your

Ground, issue-based canvassing and aiding progressive candidates.

## Dr. Carolyn J. Lukensmeyer

---

Dr. Carolyn J. Lukensmeyer is the Executive Director of the National Institute for Civil Discourse, an organization that works to reduce political dysfunction and incivility in our political system. As a leader in the field of deliberative democracy, she works to restore our democracy to reflect the intended vision of our founding fathers.
